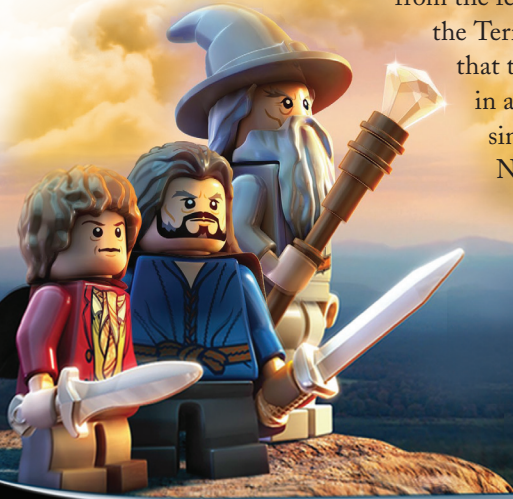
⚠ Important Health Warning: Photosensitive Seizures

HOW TO PLAY

CHARACTER SWAPPING

Different characters have different abilities. To switch characters, tap **Y**. In Free Play Mode, press and hold **Y** to select any character from the Character Grid.
