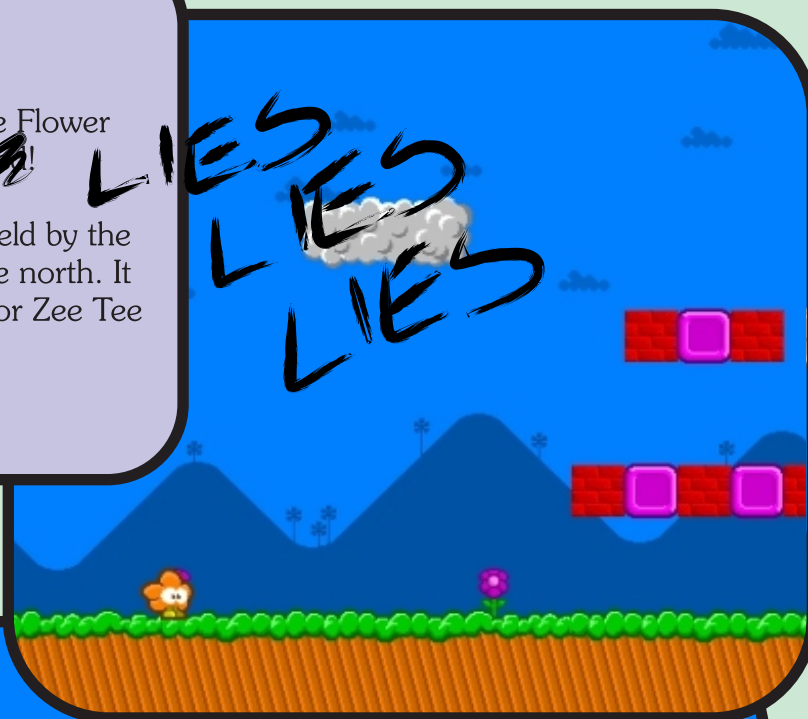

0. Additional Definitions.

1. Exception to Section 3 of the GNU GPL.
